**\*\*\*ALL OTHER-COUNTRY NATIONAL PASSENGERS TRAVELING TO THE REPUBLIC OF KOREA MUST VERIFY AND COORDINATE ALL PASSPORT & VISA REQUIREMENTS PRIOR TO TRAVELING IN ORDER TO AVOID BEING DENIED BOARDING OR DEPORTED UPON ARRIVAL\*\*\***

**\*\*\*DOD PERSONNEL MUST HAVE A "REGULAR (BLUE TOURIST) PASSPORT" TO ENTER KOREA WHILE ON LEAVE (OR OTHER UNOFFICIAL TRAVEL STATUS) PER DOD FOREIGN CLEARANCE GUIDE SECTION I.B.A HOWEVER, US MILITARY PERSONNEL ON LEAVE RETURNING TO THEIR UNIT OF ASSIGNMENT IN KOREA MAY TRAVEL ON MILITARY ID CARD AND TRAVEL ORDERS. REGULAR (BLUE TOURIST) PASSPORT IS STILL REQUIRED FOR CIVILIAN PERSONNEL RETURNING TO KOREA.\*\*\***

STARTING 01 JAN 2027, NATIONALS OF COUNTRIES/REGIONS ELIGIBLE FOR VISA-FREE ENTRY ARE REQUIRED TO GET KOREA ELECTRONIC TRAVEL AUTHORIZATION (K-ETA) APPROVAL TO BOARD A FLIGHT BOUND FOR REPUBLIC OF KOREA. THOSE WHO ALREADY HAVE A K-ETA CAN USE IT UNTIL IT EXPIRES. PASSENGERS WITH A K-ETA ARE EXEMPT FROM COMPLETING AN ARRIVAL CARD IN KOREA\*\*\***
