



JBMDL PASSENGER TERMINAL



EFFECTIVE IMMEDIATELY:

- We are required to validate parental and/or legal guardianship for all minors.
 - Proof of sponsorship can be obtained through the installation's Military Personnel Office. An example of sponsorship validation is the DD Form 1172-2.
- All dependents aged 14 and above must have an ID card IAW DoDI 4515.13. Dependents under 14 may qualify for air travel with alternative forms of identification if they don't have an issued ID card.
- Identification must be issued in the Dependent's name from a Federal, State, Local, or Tribal government.
 - A raised seal birth certificate from the city, county, state, etc is acceptable. This does not include a hospital certificate of birth. A passport is also an example of identification if available and only required when identified in the Foreign Clearance Guide.
